A member of this Association shall be disqualified from being classified as an amateur under any one of the following circumstances: (a) the member has ridden or trained horses or horse riders in any equine discipline astride for remuneration, directly or indirectly; (b) the member has assisted in training horses or horse riders astride for remuneration, directly or indirectly; (c) the member is married (or had a co-habitational relationship) to a person who is engaged or has been engaged in activities that would require that person to be classified because of the activities then occurring as a Professional; (d) the member has resided with a person who is engaged or in the last five years has been engaged in activities that would require that person to be classified because of the activities then occurring as a Professional; (e) the member has resided with or on the premise with a parent, step-parent or foster parent of the member who was, at the time of the member's residency, a Professional: (f) the member is directly or indirectly by a Professional and performs the duties of employment on the premises of a horse training operation astride a horse; (g) the member has been an apprentice cutting horse trainer at any time, or ever in their life been a trainer or assistant trainer of cutting horses.
